#### What data do we collect?

# What are your data protection rights?

- The right to data portability You have the right to request that KOK transfer the data that we have collected to another organization, or directly to you, under certain conditions.

# **COOKIES**

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

#### How do we use cookies?

KOK uses cookies in a range of ways to improve your experience on our website, including:

- · Keeping you signed in
- Understanding how you use our website
- We use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.
- We collect information that your browser sends whenever you visit our Service ("Log Data"). This Log Data
  may include information such as your computer's Internet Protocol ("IP") address, browser type, browser
  version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages
  and other statistics.

#### What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- Functionality KOK uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- Advertising KOK uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. KOK sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

# How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
